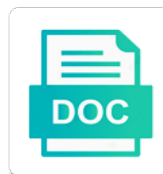
A writ of mandamus is a court order that compels a government official to perform a duty that is required by law. It is typically used to enforce the duties of public officials who are not performing their duties as required by law.
